Some countries were forced to keep their schools closed for almost two years, until March 2022. The immense task of re-opening schools after the pandemic was met with little outside support, students, or income. Although climbing these hurdles was more complex than anything they'd ever faced, the Lord called Edify to come in and help the school owners. As He turned all challenges into His great purposes, He led Edify and our partners to higher heights.

As we reflect on the journey in fiscal year 2022, we celebrate together, having seen miracles by God's grace.

- 68% growth in the number of school leaders and teachers trained during the year, from 19,200 to 32,300
- 90% growth in the number of schools reached, from 9,200 to 17,500
- 87% increase in students impacted, from 2.4 to 4.5 million

- To translate these remarkable numbers into a story, here is an example from a proprietor in Uganda. In 2021, he was laughed out of the bank when asking for a loan to keep his school running. Then the Lord led Edify to seek him out.
- Edify provided valuable resources, and our staff went far beyond simply providing loan capital. As a result,
 encouragement, dignity, and confidence were restored to the proprietor and every teacher in his school.

The incredible growth, eternities impacted, and holy moments shared are largely due to your generosity. Because of how you have walked alongside us, we have experienced over 23 percent growth in total revenue, increasing the resources for God's work from \$9.1 million to \$11.1 million. By His grace, Edify has been able to go farther; with each increase in funding, more students are given a chance to go further.

paving the way GUATEMALA

Guatemala has faced many barriers to reaching its fullest potential over the years. Although it has one of the lowest literacy rates in Central America, God has filled Guatemala with millions of opportunities.

As the nation emerges from one of the longest lockdowns in the world, Edify's partner school, Samaria Nueva Revelación, seeks to break those barriers. With the Lord's steadfast leadership, the school proprietor, Mara Marcial, has led children from her community to new heights they could not have climbed alone.

Growing up in Guatemala, Mara knew what it was like to live in an environment that did not provide quality education. However, the Lord used this hardship to develop in her a deep passion for creating opportunities for quality, Christ-centered education in Guatemala.


Mara's journey into education began 16 years ago when she followed a calling to teach the Bible to the students of Samaria Nueva Revelación. The Lord invited her into His bigger dreams for the school, and Mara began to integrate devotions and prayer into the curriculum.

The school grew over time, and so did Mara's responsibilities, as she accepted the principal position at the school. This was a big task as the school's extreme debt, bare walls, and lack of proper restrooms created obstacles on the path she desired for her students. On top of this, the school had no access to computer training, and most teachers were entirely new to technology.

Mara remembers a transformational story of a special needs student who can now communicate clearly with his teachers because of technology. "Before, he was discouraged, but now he is excited about learning and connecting at school. And we have been able to share the love of Christ with him through this process."




Average growth in enrollment of active partner schools






a holy path BURKINA FASO

Dramane Ouedraogo grew up in a Muslim family in the countryside of Côte d'Ivoire. As one of seven children, he and his siblings worked on a plantation helping their parents farm coffee and cocoa. Most of the population of Côte d'Ivoire is illiterate with little access to education, leaving future generations unable to break out of the cycle of poverty. As Dramane looked forward, there seemed to be no clear path in his life.

Little did he know, God would lead him to be the first in his family to attend school. At age seven, his father enrolled him in primary school. He often came home with questions about his homework that no one could answer, learning independence at a young age.

These early years prepared him for the next phase of his journey, where, at age 19, he graduated and moved to Burkina Faso, on his own, to continue his studies. He adjusted well to the change and excelled in his classwork.

A few years prior to moving to Burkina Faso, he had a transformational encounter with Jesus Christ during a 30-day Ramadan fast, which changed his life forever. He recalled God's voice coming to his heart that night, asking, "If you die today, will you go to heaven?" He immediately reflected on his dedication to praying five times a day and fasting frequently. He had always been so committed, so why wouldn't he?

The voice of God persisted in the weeks to follow, and Dramane decided to bring his questions to the respected Muslims in his community. No one could provide an answer, but God's grace continued to pave the path in front of him even when it seemed he was utterly alone. The answers came through two classmates inviting him to a Saturday church event. As a newcomer, Dramane received prayer along with his first New Testament Bible. For the first time in his life, Dramane read the words

"Jesus is the Way, the Truth, and the Life," John 14:6 (NIV). The Holy Spirit led him through the Scriptures as the school year continued, and verses jumped off the page and into his heart.



He returned home during summer break with new hope; however, he received a harsh rejection from his family and a complete withdrawal of his tuition support. Obstacles multiplied in front of Dramane as voices swirled around him, "We sent you to school for an education, not to become a Christian."



Yet God continued to lead Dramane. With the support of his local church and part-time teaching opportunities, he persevered in his studies with excellence. Dramane went on to attend the University of Ouagadougou, graduating with an MA in Foreign Civilization. Following graduation,

he began serving as a principal at a Christian high school, following the path in front of him and deepening his love for education.

One Sunday morning, Dramane found himself at an Edify presentation at his local church. He immediately felt called to Edify's mission and volunteered at a leadership training. Still, there was one more detour before God would lead him back to Edify.

Dramane received a Fulbright scholarship to Columbia University and was honored to have the opportunity to take his education a step further in the United States. After years of intense studies,

he graduated from Columbia with an MA in International and Comparative Education. Upon his return to Burkina Faso in 2018, God opened the door for Dramane to become Edify's Country Director of Burkina Faso.

The Lord continues to shape Dramane as a steadfast, compassionate leader. Amidst numerous terrorist attacks in the past several years, which have displaced millions of families, Dramane has continually led, without fear, through organizing prayer calls and team gatherings. In the same way that Dramane has steadily walked with his team, he has led his family with persistence and faith. He

introduced his younger brother to Christ and has recently grown his family, welcoming a baby girl into the world. With trust cultivated over a lifetime, Dramane continues to dream big as he follows the Lord's path, ushering an entire generation of Burkinabes into God's goodness.



management discussion & analysis **2022**

Total revenue for the year from donations and other income was \$11.1 million, a 23% increase from \$9.1 million in fiscal year 2021. Program expenses totaled \$8.4 million, an increase of 25% from the prior year's total of \$6.7 million. Program activity continued either in person or in a virtual setting on a country-by-country basis. Programs delivered during the year impacted 17,583 low-fee independent Christ-centered schools in 12 countries. Training was provided to 21,599 school leaders and 10,772 teachers. Lending partners funded 1,586 loans to 1,432 different schools at an average loan size of \$3,936. Of these loans made to schools, 1,160 were COVID-19 recovery loans at an average loan size of \$1,799 and 426 standard loans at an average loan size of \$9,752.

FISCAL YEAR 2022 REVENUE OF \$11.1 MILLION EXCEEDED TOTAL EXPENSES OF \$10.7 MILLION, RESULTING IN A SURPLUS OF \$473 THOUSAND. THE SURPLUS AROSE FROM TOTAL REVENUE BEING 10% ABOVE PROJECTIONS, WHILE TOTAL EXPENSES BEING SLIGHTLY OVER BUDGET BY 1%.

Edify increased the board designated cash reserve by 24% from \$2.0 million to \$2.5 million. Restricted cash on the balance sheet to fund specific programs decreased by 60% at fiscal year-end to \$675 thousand from \$1.7 million in

2021. This was largely due to Edify programs and services expanding and being fully operational. Approximately 97% of the restricted funds are planned for disbursement in fiscal year 2023 to fund their respective designations.

Edify diligently seeks to distribute the highest percentage possible of donations to fund training, loans to schools, and education technology programs to improve Christ-centered education in the 12 countries where we work. Program expenses in fiscal year 2022 were 79% of total expenses or \$8.4 million. Of this amount, \$6.9 million went for programs that included Christian character development for students, school proprietors and teachers, specific COVID-19 recovery interventions, business training for proprietors, education technology training for teachers, mobile learning devices in primary school classrooms, and curricula and life skills training for students.

Program expenses also include net new capital of \$1.5 million in the form of loans that were disbursed to lending partners overseas to make loans to school proprietors. Lending partners were able to disburse \$6.2 million in new loans due to schools opening back up and being receptive to receiving loans again.

CUMULATIVE LOAN CAPITAL DEPLOYED BY EDIFY INTERNATIONALLY FOR SCHOOL LOANS

WAS \$13.6 MILLION FROM FISCAL YEAR 2010 TO 2022. CUMULATIVE LOANS TO SCHOOLS BY LENDING PARTNERS AND DIRECTLY FROM EDIFY WERE \$46.0 MILLION OR 338% OF THE LOAN CAPITAL FROM EDIFY BECAUSE OF RECYCLED PRINCIPAL REPAYMENTS.

Loans to lending partners are in local currency and often have a grace period on the front end where no payments are due. As a result of the favorable non-market loan terms, for GAAP purposes (generally accepted accounting principles), our independent CPA firm has classified these loans to lending partners as grants. These loans with nonmarket terms in depreciating currencies do not appear on our balance sheet. We receive a full audit each year by our independent CPA firm with the findings reported directly to the board-appointed Audit Committee. Board member Kurt Knapton, MBA, currently serves as the Audit Committee Chairman.
